1 The 'External Investment Manager Indirect Cost Ratio (ICR)' is as at 30 June 2018 and includes the investment management cost, estimated performance fee, estimated recoverable expenses and any other indirect costs of the appointed investment manager.

2 The Total estimated management cost' includes our administration fee, and the Indirect Cost Ratio of the appointed investment manager. The management cost is expressed as a percentage of the total average assets of the investment option.

Investing transaction costs ('ITC')

The ITC are charged by the appointed investment manager of each investment option, and aim to ensure that each investor shares the transaction costs associated with their investment decision to either enter or exit an investment option.

It is not a fee retained by us. The cost is deducted from your investment account or switch amount upon entry into an investment option, and is comprised of both the buy and sell spread combined. It is an estimate to cover the investment options transaction and operational costs. It is not an additional fee paid to the fund manager of the investment option, but is retained to cover those transaction costs.

The ITC do not include the Management Costs (refer to page 2). The ITC for each investment option are set out under 'Investing transaction costs' in the table below.

Indirect transactional and operational costs

Transactional and operational costs incurred from changing the portfolio's underlying asset mix may be offset against investing transaction costs to the extent that they have not already been fully utilised.

However, if there are no amounts to offset against, which is usually the case; these costs are instead paid out of the investment option's assets as and when incurred. The transactional and operational costs for each investment option are set out under the 'Estimated transactional and operational costs' in the table below.
