Compact menu

When you open a new Asset Administrator Investments or Asset Administrator Super account, you now have the choice between our Full menu option and our Compact menu option which offer different investment options and have different administration fees.

The Compact menu offers a simpler, select range of term deposits, managed funds and managed portfolios. The administration fees for the Compact menu option are outlined below¹.

Administration fee – account based	\$180 p.a. for Compact menu (\$540 p.a. for Full menu)
Administration fee – asset based	0.15% p.a. of your total account balance up to \$1,000,000; and nil over \$1,000,000.

^{1.} All other fees and costs, as outlined in the relevant disclosure document, apply and are the same as the Full menu option.

The asset based administration fee applies to your total account balance, including cash and term deposits.

If you already have an Asset Administrator Investments or Asset Administrator Super account (which is our Full menu option) and wish to move to the Compact menu option, you must close your existing account and open a new account selecting the Compact menu. We may be able to assist you to transfer assets to your new Asset Administrator Investments or Asset Administrator Super account (if those assets are available through the Compact menu). For further information on how to do this, please contact your adviser or contact us if you no longer have an adviser.

We're also working on a new, more streamlined process for transferring between Full and Compact menus that won't require you to open a new account, and this will be available to you in the coming months.
